Only the following colours options are permitted.



Colour on white

Do not place on pictures



Do not rotate



Do not stretch unproportional

## Minimum size

Please don't use our logo smaller than a height of 15mm in print and 75px on screen.

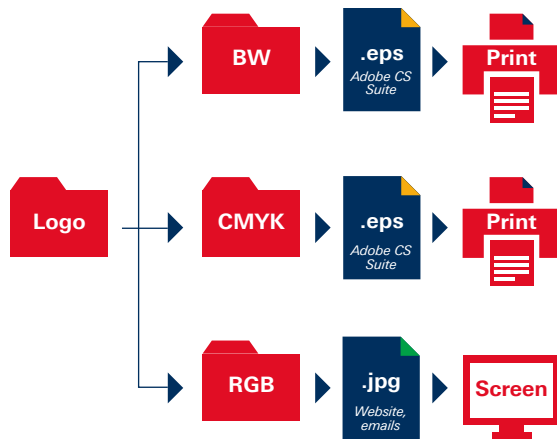


# 5.

## What logo file to use when

We have supplied you with different variations of the logo to give you the opportunity to use it across all your communication and published materials.

Below is an overview of all the different file formats and where and when to use them:



## Terms of use

Organisations who are awarded the Sword of Honour are provided with a non-exclusive, non-transferable limited licence to use a specific logo for use on their websites and printed material in accordance with these terms of use and the British Safety Council Logo Guidelines.

- The Sword of Honour logo is the property of British Safety Council and we reserve all rights in it.
- The British Safety Council does not in any way endorse organisations who are awarded the Sword of Honour, or their products or services. Therefore use of the Sword of Honour logo by organisations achieving the award to imply endorsement of products or services, either expressly or by implication, is prohibited.
- The British Safety Council reserves the right to withdraw use of the Sword of Honour logo at its discretion.
- Where organisations awarded the Sword of Honour use the logo in such a way that brings or is likely to bring the British Safety Council or our name into disrepute we have the right to withdraw permission to use the logo.
- If permission to use the Sword of Honour logo is withdrawn as a result of a breach of these terms of use or the British Safety Council Logo Guidelines

- or those outlined during the application process, it shall take effect immediately and stocks of materials bearing our name and the Sword of Honour logo shall be forthwith withdrawn from distribution and destroyed at the organisation's expense. By agreeing to these terms of use, the organisation acknowledges that this is reasonable in order to safeguard the rights of the British Safety Council. If permission is withdrawn for other reasons, we shall give the organisation a period of two calendar months notice. No expenses will be covered by us.
- The use of the Sword of Honour logo is specific to the site achieving the award and where the logo is used on a corporate website, care should be taken to identify only the site achieving the Sword of Honour.
- The Sword of Honour logo may be used only in accordance with the logo guidelines (provided with the logo).
- The Sword of Honour logo should appear exactly as supplied by the British Safety Council.
- The electronic Sword of Honour logo should be hyperlinked to [www.britsafe.org](http://www.britsafe.org) and failure to fulfil this requirement may result in the withdrawal of permission to use the logo.
